Dancer & Parent Contract 2025-2026

Please review the following dance company rules and guidelines and return to Miss Ryann no later than 9/10/25.

- I/we understand that the Sunrise and Sunset Dance Companies are an 11-month commitment and will perform year-round. Year-round enrollment in all company and technique classes at the Geneva Park District is required, including summer 2025.
- I/we understand that technique Classes are required to be taken with the Geneva Park District. Dancers may not perform or compete any SDC works without written permission from the directors. SDC members may not perform with any other dance company or studio during the season.
- I/we understand that all dancers will treat each other and their teachers with kindness and respect. Corrections and critiques will be given from instructors and should not be given from participants. Any dancer displaying unsportsmanlike behavior or unnecessary comments could be subject to dismissal from the program.
- I/we understand that all dancers will be expected to behave and practice with their best effort at all times, taking corrections and maintaining a positive, respectful attitude. If a dancer acts inappropriately during class they will be asked to sit out and parent will be notified.
- I/we understand that practices and scheduled performances are mandatory.
- I/we understand that if a dancer misses rehearsals during time choreography is being set, they may be removed from the section. It is the dancer's responsibility to learn any missed choreography during their own time. Attendance is most important during the time the choreography is being set on the dancers.
- I/we understand that all dancers are required to attend all rehearsals and technique classes the week of a performance or competition. Missing class or rehearsal the week of competition could result in dancers being unable to

participate in the performance. Illness or school events that require a grade may be considered as an exception.

- I/we understand that dancers should arrive early and prepared to participate at all practices and performances. Late arrival could result in the dancer being unable to participate.
- I/we understand that dancers should be picked up promptly after rehearsals and performances. If you will be late to pick up your dancer, please call or text Miss Ryann or message on the Band app. If needed please call the office and get a message to the instructor. Sunset Community Center 630-232-4542.
- I/we understand that dancers should arrive in appropriate attire for rehearsals. Attire for rehearsals: leotard, tights, and hair securely pulled back (fitted shorts or leggings are allowed). For technique classes, dancers will follow the dress code listed in the program book for each style. For ballet classes, female dancers should wear a leotard, tights, and hair in a bun and fitted pants or leggings and a white t-shirt for males.
- I/we understand that participants are responsible for all required costumes and team gear purchases and fees must be submitted by the deadline. Late fees may be required or denial of participation may be necessary if payment is not received on time.
- I/we understand that competition fees must be paid by the instructed date in order to participate. Fees turned in after the instructed date will have a late fee or may not be accepted. Please keep in mind that competition fees are non-refundable.
- I/we understand that each dancer is responsible for their dance costumes, makeup and accessories when at a competition or event. Any missing costume pieces would result in point deductions at competitions, therefore the dancer may not be able to perform. Competition fees will not be reimbursed.
- I/we understand that dancers and observers can be judged based on good sportsmanship towards other teams at all competitions and events. All participants, including parents, friends and family observers must show respect to other competitors at all events. Any dancer or observer may be asked to leave an event if they fail to demonstrate supportive and positive behavior.
- I/we understand that the Sunrise and Sunset Dance Companies are no-cut teams. However, instructors may divide groups by skills/ability. Instructors have the right to place team members in age/level groups they see fit.



I have read the Sunrise and Sunset Dance Company Handbook and understand that it is a **binding contract** holding me responsible for adhering to the above verbiage until the season ends in August 2025.
