# Geneva Park District Kids' Zone Registration Information

## Registration Procedure

**Detailed Participant Profile**  
Information is collected electronically and is not required by registration day! Registered participants will receive information on how to access ePACT, the program we use to collect important information about your child such as allergies, pick up person permissions and more!

All registration and payments will be accepted at **Sunset Community Center, 710 Western Avenue** or the registration form may be emailed to [info@genevaparks.com](mailto:info@genevaparks.com) or faxed to **630-232-4569** *Online registration is not available for Kids' Zone.*

- A \$50 registration fee is due at the time of registration.
- Currently enrolled students will be given first opportunity to register.
- Payment is due in full. You may pay the tuition in full at time of registration or sign up for EZ Pay; automatic monthly payments from a debit or credit card; Visa, MasterCard, Discover or American Express.
- Child must attend a Geneva District 304 school to participate.
- Registration forms received after August 1st will be placed on a waitlist and may not be eligible until September 15, provided space is available. After September 15, 2026, participants must be registered by the Wednesday prior to the week they wish to begin attending, provided space is available.

**Completed registration includes: Registration Form, \$50 registration fee and payment/arrangement.**

## Cancellation & Payment Information

The Geneva Park District office must receive an application for refund by 10 business days prior to the child's last day of attendance. **An application for refund must be completed as cancellation verification.** Refunds will be prorated. Refunds will be given if the participant moves out of the district, withdrawals from the program or for an extended medical leave (5 or more consecutive days) with a doctors note. Refunds or credits will not be given for snow days, e-learning days, vacation, illness, extracurricular activities, disciplinary reasons or other temporary child care arrangements.

For EZ Pay payments, the first payment will be charged on **August 1, 2026**. Eight (8) additional monthly payments will be charged on the first business day of the month from September 1, 2026 through April 1, 2027. **Please note: we cannot split payments between multiple credit cards or family members.**

Credit / Debit cards that are declined will be charged a \$25 service fee by the Geneva Park District. In addition, a late fee of \$10 will be charged. After the 10th of the month, the child will be suspended from the program until the account is brought up to date. After 30 days the child will be withdrawn from the program.

## Important Dates

- **February 16:** Priority Registration forms are due from currently enrolled Kids' Zone Participants. *(After February 16, you will no longer be guaranteed a spot in the Kids' Zone program and your registration forms will be placed in general registration to be randomly processed beginning March 10.)*  
*Current KZ participants: You are only guaranteed registration for the status your child is currently attending. If space is available we will randomly process additional requests.*
- **March 9:** New participant registration forms are due.
- **March 10:** Random processing of new participant registration forms begins. You will receive an email confirmation indicating your registration status of enrolled or waitlisted. **\*Please allow up to 1 week for random processing to be completed.**
- **August 1:** First payment charged for EZ Pay.

Attention!  
Registration packets received after August 1st will be placed on a waitlist and may not be eligible until September 15, provided space is available.

## 2026-27 Registration Fees



*\* Times, prices, and dates are subject to change. Monthly fees are based on the total program fee divided by 9 equal monthly payments. If you enroll in our program after school begins your total amount due will be based on the remaining days left in the school year. Therefore, your first payment will be higher, and remaining payments will be in line with our monthly payments. We do not take payment in May, however the children attend thru the end of the school year.*

By enrolling my child in the Kids' Zone program for the 2026-27 school year, I understand the following:

1. The Kids' Zone program is open according to the official school calendar of School District 304 and is closed during inclement weather days. \*Schedule is subject to change.  
Institute Days, non-attendance days and school holidays are not included in the installment plan.  
During these days we offer Day Off Fun Zone, which requires an additional registration and fees.
2. I am responsible for the payment of the non-refundable \$50 registration fee, due at the time of registration.
3. I am responsible for the payment of monthly fees, which are due by the first of each month. The payments will be made in nine installments.  
I authorize the Geneva Park District to charge the credit card listed below for Kids' Zone payments. \$50 registration fee will be charged at the time of registration. The first payment will be charged on August 1, 2026 and eight (8) additional payments will be charged on the first day of each month beginning September 1, 2026 through April 1, 2027. You will not receive a bill. Payments that are denied due to insufficient funds or credit cards that are declined will be charged a \$25 service fee by the Geneva Park District. In addition, a late fee of \$10 will be charged. If a parent/guardian is delinquent on the child's account (payment has not been received by the 10th of the month that the payment was due), the child will be suspended from the program until the account is brought up to date. After 30 days the child will be withdrawn from the program.
4. In the event of any absences during the program hours/activities, I will be responsible for fees for time reserved, not actual time spent at the program. I understand that it is my responsibility to call or email the site and inform them of any absences. Failure to do so may end up in dismissal of the program. Also, if my child/ward is ever picked up after 6pm, I agree to adhere to the policy and fees regarding late pick-up, as stated in the Kids' Zone Program Policies and Details Manual.
5. The Geneva Park District office must receive application for refund by 10 business days prior to the child's last day of attendance.
